Income Guidelines Maryland Legal Aid's services are free for financially eligible individuals which is based on income and assets available to the household. Household income must be below 125% of the federal poverty income guidelines.

Households headed by women are also more likely to experience poverty. In Maryland, women's median earnings in 2013 were almost \$10,000 less than men's. There is a significant gap in earnings for women who have only a high school diploma or less.

The poverty guidelines are the other version of the federal poverty measure. They are issued each year in the Federal Register by the Department of Health and Human Services (HHS). The guidelines are a simplification of the poverty thresholds for use for administrative purposes — for instance, determining financial eligibility for certain federal programs.

Current HHS Poverty Guidelines - Maryland Department of Labor

While Maryland's child poverty rate remains above the annual rates prior to the recession, Maryland is significantly below the national rate of 21.7%. The two Maryland jurisdictions with the highest child poverty rates in 2014 were Somerset County and Baltimore City, with rates of 32.6% and 32.2% respectively.

2013 FEDERAL POVERTY GUIDELINES (FPG)

Low-income families are those that make less than 200 percent of the federal poverty guideline, \$21,780 for a single person or \$44,700 for a four-person household. Maryland Medicaid Children under the age of 18 who live in low-income families may qualify for Maryland's Medicaid Program.
