### **Consideration of Laws and Regulations in an Audit of ...**

The audits shall be conducted in accordance with this Law, the International Standards of Auditing (ISA), and the Code of Ethics for Professional Accountants. Financial statements shall be audited by certified auditors employed by the auditing firms. A competent body of the legal entity shall make decision on the choice of auditing firm.
